PARTICIPATION AGREEMENT & WAIVER

(For minors/under 18 years age – completed by Parent/Legal Guardian)

By signing this document you will waive certain legal rights, PLEASE READ CAREFULLY!

IN CONSIDERATION of allowing my minor child(ren)/ward(s) as listed on the reverse of this form and hereinafter called “the Participant(s)”, to participate in the programs, activities and events of the Thorncliffe Sports and Recreation Club, **I ASSURE TO YOU THAT:**

1. I am the parent/guardian of the participant(s) listed in Part B of this document, having full legal responsibility for decisions regarding the participant(s).
2. I believe that the participant(s) is/are physically, emotionally and mentally able to participate in the programs, activities and events of the Thorncliffe Sports and Recreation Club.
3. I hereby acknowledge that I am aware of the risks and hazards associated with or related to soccer. The risks and hazards include, but are not limited to injuries from:
 - a. Executing strenuous and demanding physical techniques in soccer;
 - b. Dry land training including weights, running and massage;
 - c. Grass, turf, wood and other surfaces including bacterial infections and rashes;
 - d. Falls to the ground due to slippery, uneven or irregular terrain or surfaces;
 - e. Collisions with walls and soccer equipment;
 - f. Failure to properly use any piece of equipment or from the mechanical failure of any piece of equipment;
 - g. Extreme weather conditions which may result in heatstroke, sunstroke or hypothermia;
 - h. Contact, colliding or being struck by other participants, spectators, equipment or vehicles;
 - i. Vigorous physical exertion and strenuous cardiovascular workouts;
 - j. Exerting and stretching various muscle groups; and
 - k. Travel to and from competitive events and associated non-competitive events which are an integral part of the Organization’s activities.
4. Furthermore, I am aware that the participant(s) may:
 - a. Sustain injuries in soccer that can be severe, cause spinal cord injuries and even be fatal;
 - b. Experience anxiety while challenging him/herself during the activities, events and programs;
 - c. Come into close contact with other participants, including the possibility of accidental and unexpected contact;
 - d. Risk of injury is reduced if he/she follows all rules established for participation; and
 - e. Risk of injury increases as he/she become fatigued.

I UNDERSTAND AND AGREE, on behalf of myself, my heirs, assigns, personal representatives and next of kin that my signing of this document constitutes:

5. I am registering the participant(s) willingly and the participant(s) is/are participating voluntarily in these activities, events and programs.
6. I agree that there are risks in soccer as described above and the participants will be exposed to these risks and hazards.
7. I agree to accept all these risks and hazards and be responsible for any injury or other loss which the participant(s) might receive while participating in these events, activities and programs.
8. If something happens to the participant(s), I release the Organizers of responsibility for any claims, demands, actions and costs which might arise out of the participant(s)’s participation. I understand “Organizers” to mean: The Thorncliffe Sports and Recreation Club and their directors, officers, members, employees, volunteers, coaches, officials, participants, clubs, agents, sponsors, owners/operators of facilities, and representatives.

- 2- **REFUNDS:** No refunds will be processed for any event after the 1st day of practice/game in any given year.
- 3- We cannot play in any sanctioned soccer game until after this registration form has been validated.
- 4- I have reviewed the Participation Agreement/Waiver and my signature affixed hereto indicates my agreement with such Participation Agreement/ Waiver.
- 5- I agree with, abide and to be bound by the bylaws, policies, rules and regulations of the Thorncliffe Sports and Recreation Club.
- 6- I accept sole responsibility for personal possessions and athletic equipment.
- 7- I accept all liability for any damage to the playing equipment caused by my carelessness, negligence and/or improper handling.
- 8- Participants will only be allowed to play in proper/appropriate soccer shoes (cleats/running shoes) and uniform. Jeans/cargo/dress pants/shirts, hats, boots, sandals are not allowed for the game. SHIN PADS ARE MUST TO HAVE.
- 9- Participant must be on the field before the start of game. Anyone joining 10 minutes late will not receive attendance; 15 minutes late will not be allowed to play.
- 10- Participants must inform the TSRC admin regarding any miss games or late attendance in order to be considered qualified. In order to be invited to the annual banquet, participants must complete 90% attendance.
- 11- Applying for participation within this club the applicant acknowledges that he or she may forfeit their membership should they miss two consecutive games or their participation fall below 90% attendance. In such an event the participant is required to return all equipment and uniforms supplied to them.
- 12- TSRC does not provide 'babysitting' services but healthy sports activities, for which the parents' engagement is very important and essential. So, one of the parent MUST stay around when the child is playing in the field/Gym.
